

## **AUTHORIZATION REQUIREMENTS FOR OPENING AN INTERNET CAFÉ**

As per the Board Decision No 15/ICT.APP/RURA/2009 of 6th November 2009 establishing regulatory framework governing the operations of Internet café in Rwanda, every applicant must fulfill the following application requirements:

- (a) Fill an application form;
- (b) Mention the location of business;
- (c) Proof of payment of the required authorization fee of **Rwf 15,000** payable on RURA Account No 1201127 in the National Bank of Rwanda ;
- (d) If the applicant is not an individual business, must provide Memorandum and Article of Association fill the following application requirements.
